

# The Public Slavery Acts of Abe Lincoln

*Publisher's Note: This is the third part of a three part series concerning the facts and events that brought about the abolition of Christian America, the former united States of America.*

As we have proven in previous issues of this series, Lincoln's civil (un-civil) war was a war of commerce having absolutely nothing to do with slavery. Ever since the [Lieber Code](#) (Martial Law) was proclaimed in full effect by Lincoln, all Americans, be they northern, southern, black, or white, have become public slaves of commerce. The [Lieber Instructions](#) extended The [Laws of War](#) and International Law beyond Washington, D.C. by imposing foreign law upon all the states. [Christian Common Law](#) and [Constitutional Common Law](#) were replaced by the Field Code so that each State would become a member of the corporate Federal commercial franchise (now regulated by the [Uniform Commercial Code](#)). As the conquerer, Lincoln and his Federalist government then reformed (re-formed) the States through implementation of the [Reconstruction Acts](#). These Acts changed the legal status of the States to that of mere branch offices of the corporation.

In [Article I, Section 4](#) of our now nullified Constitution, it was the States who were to determine the qualifications of their own voters for state offices since those same qualifications were adopted for federal offices unless changed by Congress. The authors of our original Constitution never imagined that the national Congress would set the qualifications for voters in every election from President to local sheriff. It was, and still is, obvious that the original Constitution reserves to the States the power to set voter qualifications in state and local elections. The illegal [Civil War Amendments](#) to the [Martial Law Constitution](#) ([Thirteenth](#), [Fourteenth](#), and [Fifteenth](#) Amendments) changed this.

The new elections process was then used to provide surety (collateral) for the Northern industrial and foreign bondholders of the 10-40 and 5-20 debt bonds from [Lincoln's War](#). Since Lincoln's War, [Christian America](#) (Constitutional America) ceased to exist. Once again, the corporate Federal government Lincoln created is bankrupt as declared by International Treaty in 1933. Since Lincoln, America has lived in a permanent "state of war" under emergency rule. Congress, in the [Preamble of Congressional Report No. 93-549](#), issued on November 19, 1973, stated

**"A majority of the people of the United States have lived all their lives under emergency rule... And, in the United States, actions taken by the government in time of great crisis have - from, at least, the Civil War - in important ways - shaped the present phenomenon of a permanent [state of national emergency](#)."**

Now, pay special attention to this progression:

- 1) The Supreme Court has declared that "**Congress has made little or no distinction between a state of national emergency and a state of war**".
- 2) The Law of Nations states "**the most immediate effect of a state of war is that it activates the Law of War**".
- 3) The Law of War states "**martial law is obtained during a state of war and in truth and reality, is no law at all**".

We are living under a **state of national emergency**, which is a **state of war**, which activated the **Law of War**, which provides us with **no law at all!**

An open and armed conflict or war is no longer necessary for the existence of a **state of war**, thanks to Lincoln, who is responsible for 100% of the blame. The 43rd Congress (convened under Executive Order, not Constitutional Common Law) in ***House Report No. 262*** issued March 26, 1874 declared that war exists *non flagrante bello*, a doctrine embraced and spoken by the Supreme Court, and that this is the basis of the unlawful Congressional acts called the **National Banking Acts, Reconstruction Acts, Civil Rights Acts, Voting Rights Acts**, and the so called 'amendments' to a defunct Constitution. These are all evidences that war, the actual state of war, and the martial rule imposed by them, continues openly since the Civil War, and to this day their purpose is to destroy and eliminate the **Christian states of America**.

There is a basic foundation of truth that Americans today have never heard repeated in the pulpits or in political speeches: **War is the exercise of force between political groups against each other, and the two basic political bodies are: 1) Christians; and, 2) all commercial persons supporting a dictative military character.**

Lest all Christians forget, **martial rule** and **martial law** violate the **Law and Testament of Our Sovereign Lord and Savior Jesus Christ**. According to His Word, all lawful government shall be upon His shoulders. The **Law of the Tree of Life** does not allow foreign forms of law (such as martial rule) to be imposed upon His church and state. Now, lets get down to the references so that you can see for yourself what is being said here is 'on record' and 'in the record'.

***The Federal Statutes-at-Large, Volume 12, Page 665***, admits the military necessity of funding war and, in this same act, declares the 1862 bankruptcy of the United States. This Act of Congress goes on to say that all paper currency issued by or under the act is evidence of the bankruptcy. You never knew that before, did you? The paper debt note you give to the grocer to receive food is evidence that the corporate **United States Franchise** is bankrupt.

***Volume 13, Federal Statutes-at-Large, page 69***, is where you will find the **National Banking Act** legislated by Congress in 1864. This Act established a national paper currency founded on bankruptcy through the issuance of 10-40 and 5-20 bonds, with no reserves or backing in lawful money (God's silver or gold), which is an anti-Christian monetary system founded on debt and backed by the labor (collateral) of those people (all Americans) who were 'emancipated' by Lincoln on September 22, 1862 and January 1, 1863.

The **Civil Rights Acts** can be found in ***Volume 14, Federal Statutes-at-Large, page 27***. These

Acts created a perpetual funding system based on future labors, promoting a perpetual state of war and **military rule** within each state through this system of **conscripted labor**, based in Roman (pagan) Law, which is against **Christian Law**.

All of our current codes, rules, regulations, administrative procedures, *ad nauseum*, are evidence of Lincoln's **martial law** rule instructing agents (officers) in the field (each military State). These privately administered rules and customs are enforced as general 'law', but they are really commercial or **mercantile law**. They look and appear as law, but in reality are **no law at all**.

What we have in our form of unlawful government today is a legal entity (such as a corporation) recognized by their alleged law as a **natural person**, which is not a Christian. A natural person is (by their own legal definition) those who are not a Christian.

The foundation of all these current rules and regulations, *ad nauseum*, is the blood of the 600,000 northern and southern Christian Saints shed during Lincoln's un-Holy War against the several **Christian states of the union**. It was this war that abolished government recognition of Christians. This war was founded in crimes against the several Christian states.

The corporate **United States** is not of the **Tree of Life**. Our present governments (federal and state) are un-natural entities with an evil lineage that is foreign and dangerous to His church and state. Their origin is from the fruit of the poisoned tree and lacks any standing in Law. According to **American and English Common Law**, one must come into equity (the law of equity, ie. the court) with clean hands, not bloody hands, to have any right of action. In order to avoid the common law, they act through purported courts in which their corporations seek remedy or relief of some alleged damage or loss. Their venue and jurisdiction is based on Lincoln's Acts mentioned above, not on **God's Law** or **Christian Law**. Is there any law above God? Is there any **natural person** who stands above Christ Jesus? Since the answer is a profound NO, then their courts are contrary to all Law.

Every action in a military court, ie. Circuit Courts or County Courts, is between 'licensees' quote of the bankrupt corporate entity known as the **United States**, the principal franchise. They reap the **fruit of the poisoned tree** of evil planted during Lincoln's War which is by its nature and intent that of a bankrupt and criminal entity in regard to its existence in Law. It purports to exist without Lawful creation, being created in innocent blood propagated by the evil of greed and the love of money, and therefore lacks all ability to bring any action since it is dead in Law.

That which is not of the **Tree of Life** is not of God. Why do so many Christians stand, stripped naked of their Godly Christian covering, before the un-Godly to seek perverted justice? Has every Christian forgotten that the Lord God is the Supreme Judge of all, even of evil itself? Christians stand against other Christians to seek the judgment of a law whose roots are the very foundation of evil. What brotherhood has good with evil?

Lincoln was an evil **natural person**. He was not an emancipator of men. Rather, he became this nation's greatest task master of slavery. He didn't free the black man... he chained him up to be laborers of other men's debt. Then he chained up the white man to become co-laborers and collateral for the debts of the commercial franchise owners we call 'government' today. All in all, every one of us is a slave to these owners.

Every Christian must decide who is his master. As a Christian, there should be no choice. But in

this world, we have masters who do all in their power to convince us that we are their slaves, based on their perverted law, which is **no law at all**. We must be wise to know the simple truth, and that is; **The Lord God is our Father** and none other; We obey Him and **His Law**; We hold to the truth that **Christ Jesus is His Son**; And we guide ourselves by His promise, the **Holy Spirit**. Without reminding ourselves of these truths, then we become tempted to eat the **fruit of corruption** and evil of **social security, welfare, food stamps**, and the multitude of free **benefits** offered by the masters of this world (which are not free at all).

The next question is, who are the masters of our slavery? The answer goes back to **Lincoln's Banking Acts**. Once this **unlawful fiat paper money** was established, it became the stepping stone for a multitude of additional acts to place the title of 'master' into the hands of an elite few. At the turn of the century, additional banking acts were set into place to further erode any ties to **Christian Common Law**. In 1921, the **Independent Treasury Act** suspended the Treasury Department. Of course, there was no gold or silver lawful money to back the Treasury anyway, so this was a matter of paper shuffling. From that day, the masters of our nation became the **Federal Reserve System**. They control all facets of the United States corporation (**U.S. Incorporated**). This un-Godly list of task masters are the branches of the poisoned tree, and we eat of their fruit.

The **Rothschild** family and their banking companies top the list in ownership shares. **Lord Rothschild** was the administrator of the vast **Cecil Rhodes** (DeBeers diamond) estate. Both were avowed atheists. Next on the majority ownership list is the **Warburg** family, followed by minority owners hiding among corporate names such as **Chase Manhattan Bank (Rockefeller Family, et al )**, **Kuhn Loeb Bank**, **Goldman Sachs Bank**, **Lazard Brothers**, and **Israel Moses Seif Banks**. Not only do they own the so called 'banks' of the world, they also own the major stock brokerage houses. These are paper shufflers extraordinaire. They literally rule and own the material world.

So, who enforces the whims of these masters of slavery? First, the mighty industrialized military machines they own and control. Second, the **lawyers** who have sworn their allegiance to their rules and secrets. This all appears to be very confusing considering that the **United States** has been bankrupt since **Lincoln's War**, but the world has swallowed a bitter pill of lies, and like all masters, when they throw out some crumbs for the slaves, we all accept it with further pledges of labor.

Wake up Christians. All the fruit of the poisoned tree is to be avoided and destroyed wherever found. God has told us to cut down and burn this tree so that it can no longer propagate and infest **His Estate**! As caretakers of **His Estate**, we have allowed this tree to grow, multiply, and infestate God's property. Instead of destroying this tree and it's off-spring, we encourage it to grow more by eating of it's fruits. The more we eat, the more **Christian America** dies. But, just to please ourselves, we occasionally eat of the fruit from the **Tree of Life** and tell ourselves "see... we're still Christians" . How can we eat God's fruit and evil fruit at the same time and not be confused?

God looks at the Christian through Christ and sees one whose sins are **white as snow**. The imperial powers of this world (ex.: civil circuit court military tribunal judges) see Christians through the codes, regulations, and unlawful laws as a slave of labor whose existence is from the pit of blackness. In like contrast, the **Common Law** states that **"the Law of God and the Law of**

**the Land are one and both preserve and favor the common good of the land" - Bouvier's Dictionary of Law, 1856. The **Law of War** states that "**the laws are silent amidst arms**" -Ibid Bouvier's.**

God's Law and man's law are enemies. **God is no respecter of persons Acts 10:34**, but the evil **natural man** is and his un-Godly acts, regulations, and unlawful administrative procedures prove this. Under the **Laws of War**, **Common Law** and **Constitutional Law** are silent and suspended. They have no voice... no force... and no effect.

If we are joint heirs with Christ Jesus, then why do Christians not protect that which our Father has given us through His inheritance? The earth is His and the fullness thereof.

Since most Christians have never been exposed to **Christian Common Law**, it's time to introduce some **Maxims of Law**. Maxims were cited in the Common Law courts as an undisputable truth, a fundamental principal, and the rule of conduct. These Maxims have not been used in the courts since Lincoln's War suspended Common Law and the Constitution. Many are taken from **Broom's Maxims, (1845)**, and they will sound to a Christian much like reading **Proverbs**.

***Summa Ratio est quae pro Religione facit* - "If ever the laws of God and man are at variance, the former (God's Laws) are to be obeyed in derogation of the latter."**

***Ratio est radius divini luminis* - "Reason is a ray of divine light."**

***Malum quo communius eo pejus* - "The more common the evil, the worse."**

***Malus usus est abolendus* - "An evil custom is to be abolished."**

***Lex est sanctio sancta, jubens honesta, et prohibens contraria* - "Law is a sacred sanction, commanding what is right and prohibiting the contrary."**

***Haeredem Deus facit, non homo* - "God and not man, make the heir."**

***Disparata non debent jungi* - "Unequal things ought not to be joined."**

***Accusare nemo debet se, nisi coram Deo* - "No one ought to accuse himself, unless before God."**

Could you imagine the un-Godly courts existing today allowing such Maxims to rule their courtrooms? Yet, until **Lincoln's War**, such Maxims were the rule of the court. **God's Word** was enforced in man's Constitutional law from 1776 until 1861. Since then, God and Christ have no place within the martial rule courts and military tribunals we have today.

What Lincoln created can be destroyed only when Christians begin to start cutting off the branches of the poisoned tree. Complacency of Christians cannot be tolerated. What is right is right... what is wrong is wrong.

The next time your child or grandchild comes home from school proclaiming how Lincoln freed the slaves, correct him and read the three parts of this series to him. Lincoln was ruled by evil, and his actions were anti-Christian. The facts are the facts. It is our duty, as Christians, to see that the blood of our ancestors shed during Lincoln's un-Holy War was not for naught.

Power, especially overgrown power, births an insatiable ambition and sets all the power hungry minds to work in order to enlarge it. Therefore, infringements on the people's liberties are not generally made all at once, but so gradually as hardly to be perceived by the average Christian, that before they are aware of the snare, they are trapped and cannot free themselves.

The purpose of civil government in any nation is to defend the lives, liberties, and property of the people, yet every government of tyranny has invaded these Rights, and the current **United States, Incorporated** is no exception. **Lincoln's War** was the death sentence of **Christian America**, and we have all been robbed of our property and liberties through the doctrines of **privilege** and **benefit**. This federal corporation has already made claim on the people and their property as a surety for unlawful debts as if all the people were made for them and not they for the people.

**Lincoln's War** is not over. Christians must take back America now or lose it for good. God be with us in our fight for **His Truth**.
